# Terms of Reference Citizen Assembly Advisory Panel

### **Purpose**

This advisory group has been convened by Natural Resources Wales to support the development and delivery of a citizen assembly as part of the Nature and Us programme. It is intended to build on the work carried out in the Nature and Us National Conversation, and to employ a 'Team Wales' approach to this work.

The outcomes of the assembly will directly shape the vision for our natural environment in Wales, the actions we take collectively with citizens for both nature and for people, and will guide how NRW and other organisations work

The Advisory Panel will be facilitated and managed by the Centre for Deliberative Research at NatCen Social Research, who are leading on the design and delivery of the citizen assembly.

The Advisory Panel will feed into four key areas:

- 1. The core questions framing the overall citizen assembly
- 2. The evidence chosen to be presented during the assembly
- 3. The delivery tools employed throughout the session
- 4. Working together to carry forward the recommendations made by the assembly

### **Ways of Working**

Panel members agreed to bring the following to the group:

- 1. Willingness to create a shared vision, and purpose
- 2. Respect and trust amongst all
- 3. A space where everyone feels able to contribute
- 4. A space where everyone feels their contributions are heard.
- 5. Collaboration across organisations and individuals
- 6. Mutual respect in the context of trust in the common goal across different views and experiences
- 7. Shared learning from one another
- 8. Engagement across sectors, including local government, community organisations, town councils, and perspectives included ranging from agriculture to marine and other nature-focused organisations



### **Programme Contributions**

Panel members will contribute the following throughout and after the programme:

- 1. Robust and trusted evidence sources and key messages for the citizens' assembly
- 2. Expertise, knowledge, ideas and experiences from the wide range of perspectives represented on the panel
- 3. Integration with other citizen engagement happening across Wales on the topic of visions of a good life to support societal transformation.
- 4. Links to Ministerial priorities, climate and nature emergencies, individual and group stories, and with other involvement activity across the wellbeing goals to ensure interdisciplinary opportunities are identified and realised.
- 5. Support the communication and implementation of the shared vision. This involves helping communicate outcomes clearly with the public and with other sectors, while feeding it into your own work.
